#### Approval of Termination of Athletic Director

Mr. Tobin made the motion, which Ms. Kreisher seconded, to approve terminating Bill Perkins as the district's athletic director, effective 13 November 2012. The motion passed by a unanimous voice vote.

#### Approval of Professional Staff Transfers

Ms. Kreisher made the motion, which Mrs. Fiedler seconded, to approve the following professional staff transfers, effective 13 November 2012: Bill Perkins to the position of half-time health teacher at Bloomsburg High School and half-time physical education teacher at W.W. Evans Elementary School, and Jeff Archey to the position of full-time driver's education teacher at Bloomsburg High School. The motion passed by a unanimous voice vote.

### Approval of Classified Staff Transfers

Mrs. Fiedler made the motion, which was seconded by Ms. Kreisher, to approve transferring Bloomsburg Middle School Personal Care Aide Amy Fuehrer to the position of Memorial Elementary School Personal Care Aide, effective 13 November 2012. The motion passed by a unanimous voice vote.

## **Approval of Interim Athletic Directors**

Mrs. Fiedler moved to approve Dan Bonomo, Steve Bressi, and Marc Freeman as interim athletic directors, at a rate of \$300/month each, effective 13 November 2012. Ms. Mathews seconded this motion, and the motion went on to pass by a unanimous voice vote.

## **Approval of School Director**

After conducting interviews (with Theresa Klinger, Joshua Klingerman, Normal Mael, Rebecca Neyhard, Francis Peters, and Jeffrey Ralston) for the position of school director, ballots were distributed to board members, with two votes tallied for each of the following candidates: Theresa Klinger, Normal Mael, Francis Peters, and Jeffrey Ralston.

Mr. Tobin made the motion to move into executive session to discuss the interviews. Ms. Kreisher seconded this motion and the motion then passed by a unanimous voice vote. The executive session began at 8:15 p.m. and ended at 8:24 p.m. after a motion by Ms. Mathews, a second by Ms. Kreisher, and a unanimous voice vote.

At this time, Mr. Tobin moved to approve Norman Mael as a Bloomsburg Area School District director, effective 3 December 2012, to complete the term of Mr. David Klingerman Jr., which will expire the day before the December 2013 reorganization meeting. Ms. Mathews seconded this motion, which then passed by a unanimous voice vote.

At 8:30 p.m., Ms. Kreisher moved to adjourn the meeting and Mr. Hock seconded this motion. The motion passed by a unanimous voice vote and the meeting was adjourned.
