NEW BUSINES

Approval of Homebound Instruction Request

Mr. Hock made the motion, which Mrs. Fiedler seconded, to approve homebound instruction for a Memorial Elementary School student, retroactive to 17 April 2012 and lasting for a period of at least 20 school days. The motion passed by a unanimous voice vote.

Approval of Administration to Solicit Bids for Oil Tank Removal

Mrs. Fiedler made the motion, which was seconded by Mrs. Crawford, to approve granting permission to the administration to solicitor bids for oil tank removal. The motion passed by a unanimous voice vote.

Approval of Out-of-State/Overnight Field Trip Requests

Mrs. Fiedler made the motion, which was seconded by Mrs. Rupp, to approve the following out-of-state/overnight field trip requests:

- Class of 2012 to Great Adventure Six Flags in New Jersey on 5 June 2012, at no cost to the district;
- FBLA to San Antonio, Texas for the FBLA National Leadership Conference from 27 June 2012 3 July 2012, at a cost to the district of \$5,160.00; and
- Eighth-grade team to Washington DC on 1 June 2012, at no cost to the district.

Ms. Mathews moved to separate out the three field trip requests into three separate motions, and Mr. Tobin seconded the motion. The motion passed by a unanimous voice vote.

Mr. Hock moved to approve the trip of the Class of 2012 to Great Adventure Six Flags in New Jersey on 5 June 2012, at no cost to the district. Mr. Tobin seconded this motion, and it then passed by a unanimous voice vote.

Mrs. Fiedler made the motion, which was seconded by Mr. Tobin, to amend the motion pertaining to the FBLA trip to read: Approved the trip of FBLA to San Antonio, Texas for the FBLA National Leadership Conference from 27 June 2012 – 3 July 2012, at a cost to the district of \$4,308.00. The motion passed by a voice vote of seven yes votes to two no votes (being Mrs. Crawford and Ms. Mathews).
