Attendance

A special meeting of the Bloomsburg Area School District Board of Directors was called to order at 5:00 p.m. on Monday, 17 November 2014, in the district office board room, followed by the pledge to the flag. Directors in attendance were: Mr. Brent Hock, Mrs. Tina Howell, Mr. Justin Hummel, Mr. Joshua Klingerman (arrived at 5:05 p.m.), Mrs. Sandra Rupp, and Mr. Thomas Tobin. Mr. Terry Kramarz, Ms. Marianne Kreisher, and Mr. Joe Yodock were absent from the meeting.

Bloomsburg Area School District administrators in attendance were: Mr. Dan Bonomo, Mr. Steve Bressi, Dr. Cosmas Curry, and Mr. Marc Freeman.

RECOGNITION OF VISITORS & PERSONS WISHING TO SPEAK

There were no guests wishing to address the board at this point in the meeting.

EXPULSION HEARING

A private expulsion hearing was held for Bloomsburg Middle School Student A from 5:00 – 5:14 p.m.

EXECUTIVE SESSION

At 5:14 p.m., Mr. Klingerman made the motion, which was seconded by Mrs. Howell, to move into an executive session to discuss confidential matters regarding Bloomsburg Middle School Student A. At 5:23 p.m., Mr. Klingerman made the motion, which was seconded by Mrs. Howell, to move back into open session, and the motion passed by a unanimous voice vote.

EXPULSION OF BLOOMSBURG MIDDLE SCHOOL STUDENT A

Mr. Tobin made the motion, which was seconded by Mr. Klingerman, to expel Bloomsburg Middle School Student A through 1 December 2014, with a return date of 2 December 2014. The motion passed by a unanimous roll call vote.

EXPULSION HEARING

A private expulsion hearing was held for Bloomsburg High School Student B from 5:30 – 5:52 p.m.

EXECUTIVE SESSION

At 5:52 p.m., Mr. Hummel made the motion, which Mr. Klingerman seconded, to go into executive session to discuss confidential matters regarding Bloomsburg High School Student B. At 5:58 p.m., Mrs. Howell made the motion, which Mr. Klingerman seconded, to move back into open session, and the motion passed by a unanimous voice vote.

EXPULSION OF BLOOMSBURG HIGH SCHOOL STUDENT B

Mr. Tobin made the motion, which Mrs. Rupp seconded, to expel Bloomsburg High School Student B through the end of the 2014-2015 school year. The motion passed by a unanimous roll call vote.

EXPULSION HEARING

A private expulsion hearing was held for Bloomsburg High School Student C from 6:00 – 6:15 p.m.

EXECUTIVE SESSION

At 6:15 p.m., Mr. Tobin made the motion, which was seconded by Mrs. Rupp, to go into executive session to discuss confidential matters regarding Bloomsburg High School Student C. At 6:28 p.m., Mr. Klingerman made the motion to move back into open session. Mrs. Rupp seconded this motion, and the motion went on to pass by a unanimous voice vote.

EXPULSION OF BLOOMSBURG HIGH SCHOOL STUDENT C

Mr. Tobin moved to expel Bloomsburg High School Student C through the end of the 2014-2015 school year. Mrs. Rupp seconded this motion, which then passed by a roll call vote of five yes votes to one no vote (being Mr. Hock).

ADJOURNMENT

At 6:33 p.m., Mr. Klingerman made the motion to adjourn the meeting, and Mr. Hummel seconded this motion. The motion passed by a unanimous voice vote.
